For postharvest application on clean apples. To be applied by spraying. Should be used without dilution. Apply at a rate of one gallon of coating to 10,000 pounds of apples. For best results, clean the apples with an appropriate Decco apple cleaner before applying Apl-Lustr, or use in Decco Process by or under the supervision of the manufacturer's personnel.
