Component Information

Sodium metasilicate: Single exposure studies indicate that this material is slightly toxic to rats if swallowed (rats LD50 800-1.349 mg/kg) corrosive to mucous membranes of the gastrointestinal tract causing vomiting and bleeding) and corrosive to rabbit eyes and skin (4 hr and 24 hr exposures). No immunologic sensitization was produced in rabbits with sodium silicate bound to protein. Studies of continuous dietary administration (2400 mg/kg/day) to rats and dogs for 4 weeks resulted in excessive thirst and urination and, in dogs only, degeneration of kidney tubules. This material produced no genetic changes in standard tests using bacterial cells. It is rapidly absorbed after oral administration and excreted in the urine.
