FIRST AID

If on skin or clothing	<ul style="list-style-type: none"> Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 20 minutes. Call a poison control center or doctor for treatment advice.

For use with Agclor 310 (12.5% available chlorine) in the Decco process as specified under the direction of Decco Personnel.

Use one gallon of Decco 313 Buffer Concentrate for every three gallons of Agclor 310 with proper amount of water so that available chlorine concentrations are achieved as desired for treatment.

STORAGE AND DISPOSAL

STORAGE: Store in cool dry well ventilated area away from direct sunlight. Do not freeze.

PESTICIDE DISPOSAL: Do not contaminate water, food, or feed by storage or disposal. Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law.
