

## **Fruit & Vegetable Kleen<sup>®</sup> 441**

*Alkaline Cleaner Concentrate*

### **DESCRIPTION**

**Fruit & Vegetable Kleen<sup>®</sup> 441** (VFK 441) is a cleaner concentrate for postharvest washing of fruits and vegetables. This alkaline soap may be used on most fruits and vegetables. However, small-scale trials should be run to determine any phytotoxicity prior to general use.

### **DIRECTIONS FOR USE**

In foam washers, dilute 1 gallon of **FVK 441** with 39 gallons of water. Foam or brush this dilution on to the fruit for 15 to 30 seconds. Rinse the fruit thoroughly with fresh water. For fruit or vegetables that are hard to clean, use a concentration needed for satisfactory cleaning.

**VFK 441** may be used on all fruit and vegetables as part of the Decco Process, by or under the supervision of Decco personnel.

First use of this product should be on a trial basis until experience has been gained with it. Improper use may cause injury to the fruit or vegetable.
