DeccoNatur™ 575 is an “orange shellac” (unbleached) based fruit for use on organically grown fruits and vegetables to maintain freshness.

DIRECTIONS FOR USE

Citrus Fruit: Apply one gallon of DeccoNatur™ 575 to 10,000 to 12,000 lb of clean and dry fruit on a brush bed.

Apples: Apply one gallon of DeccoNatur™ 575 to 10,000 to 12,000 lb of clear dry fruit on a brush bed.

Pomegranates: Apply the product to clean dry fruit on a brush bed. Consult Decco personnel for usage rate.

Others: For other commodities consult Decco personnel.

Notice to buyer: Always conduct pretests on all produce commodities and varieties before commercial application.

CAUTION!! Condensation may form on apples following their removal from cold storage or for other reasons related to the manner in which they are stored, handled, processed, or packed. Subsequent evaporation of the moisture may cause white spotting of the fruit coating.
