DIRECTIONS FOR USE

Spray Application: Dilute 1 gallon of cleaner with 19 gallons of water. Spray the diluted cleaner onto fruit on a brush bed for 15 to 30 seconds. Rinse fruit thoroughly with fresh water. For fruit or vegetables that are hard to clean, use higher concentrations.

Dip Application: Dilute 1 gallon of cleaner with 19 gallons of water. Dip fruit for 30 seconds clean on a brush bed for 10-15 seconds. Rinse fruit thoroughly with fresh water. For fruit or vegetables that are hard to clean, use higher concentrations and longer exposure time.

First use of this product should be on a trial basis until experience has been gained with it. Improper use may cause injury to the fruit or vegetable.

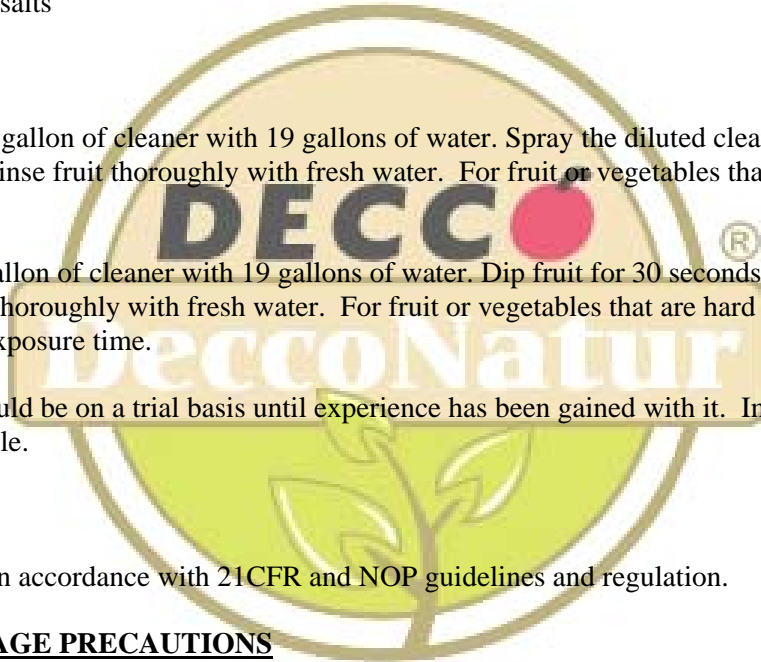
