Octylphenoxy polyethoxyethanol Single exposure studies indicate that this material is slightly toxic to rats if swallowed (LD₅₀ 4,920mg/kgMW250) practically non-toxic to rabbits if absorbed through skin (LD₅₀>16,000mg/kg, MW250) and rats if inhaled (no deaths after 1 hr exposure to 21.5 mg/l, MW624) slightly to moderately irritating to rabbit skin (4 hr exposure, MW250) and severely irritating to rabbit eyes (MW 250 and 624). Administration (average MW 624) in the diet of pregnant rats caused an increase in the number of ribs in the fetuses at a level sufficient to cause maternal toxicity. No genetic changes were observed in standard tests using bacteria and animal cells.
