Sorbitan oleate: Although rare, human case reports suggest a low possibility of allergic skin reactions, although these reports have generally been observed only in patients with chronic skin diseases. Repeated exposure in humans in controlled skin contact studies produced no skin irritation or allergy. Following repeated exposure in the feed, slight kidney and liver changes were observed in rats. No adverse effects were observed in long-term oral studies with rats. No increase incidence of tumors was observed in long-term skin application studies in mice. Single exposure studies indicate that this material is practically non-toxic if swallowed (rat LD50 >10,000 mg/kg) non-irritating to rabbit eyes and skin.
