#### DIRECTIONS FOR USE:

#### For Potato Sprout Inhibition

**Decco Aerosol 100** can be applied any time after potatoes are stored. Initial and following application doses of **Decco Aerosol 100** vary to the potato variety, sprout growth stage, storage temperature, and storage length and storage design.

**Decco Aerosol 100** is designed for use as an aerosol through Forced Air Distribution System. The application is usually performed by licensed applicators. Contact your local applicator for additional information.

#### Silver Scurf (Helminthosporium solani) Control in Storage

High initial dose of 130ppm or above may be required to eliminate Silver Scurf spores. Rates will depend on factors discussed under sprout inhibition. Applications for Silver Scurf control should be made after the storage has been filled and the cooling process has started. Additional applications may be required if the potatoes are disturbed.

- If entry into the storage area is necessary during or immediately following application before the fog has settled, protective clotting and respirators must be worn.

- Do not apply in the field.
- Do not use on seed potatoes.
- Do not allow vapors to come in contact with, or get near to, storage areas used for seed potatoes.
- Let sufficient time to elapse before using treated storage area for seed potatoes. All system components (including ducts) and building must be thoroughly cleaned and free of clove oil residue before areas are used for storage of seed potatoes.
- Decco 100 might prevent periderm formation of potatoes, therefore, it should be used only after wounds have healed completely.
