### **DIRECTION FOR USE:**

In foam washers, dilute 1 gallon of FVK 340 with 40 gallons of water. Foam or spray this dilution onto the fruit for 15 to 30 seconds. Rinse the fruit thoroughly with fresh water. For fruit or vegetables that are hard to clean, use a concentration needed for satisfactory cleaning.

For defuzzing peaches or cleaning plums and nectarines, dilute one gallon of FVK 340 with 80 gallons of water. Apply the dilution to fruit with appropriate spray nozzles, followed by a fresh water rinse. FVK 340 may be used on all fruit and vegetables as part of the Decco process, by or under the supervision of Decco personnel.

First use of this product should be on a trial basis until experience has been gained with it. Improper use may cause injury to the fruit or vegetable.
