Fruit & Vegetable Kleen® 441 is an alkaline cleaner for postharvest use. Dilute 1 gallon with 39 gallons of water. Apply the diluted cleaner onto fruit for 15 to 30 seconds. Rinse the fruit thoroughly with fresh water after application. For fruits and vegetables that are hard to clean, use a concentration needed for satisfactory cleaning.

Fruit & Vegetable Kleen® 441 may be used on all fruits and vegetables as part of the Decco process, by or under the supervision of Decco Personnel. This process may be used to create foam in any chemical foam applicator.

First use of this product should be on a trial basis until experience has been gained with it. Improper use may cause injury to the fruit or vegetable.
