Fruit & Vegetable Kleen® 451 (FVK 451) is an alkaline cleaner for postharvest use. FVK 451 is effective in removal of natural wax from apples and citrus fruit. Dilute one part of FVK 451 with 49 parts of water prior to use. For heavy natural wax deposits, use FVK 451 in more concentrated form. Use a concentration needed for satisfactory cleaning. Apply diluted cleaner by spraying onto the fruit on brush bed for 15 to 45 seconds, rinse thoroughly with water.

First use of this product should be on a trial basis until experience has been gained with it. Improper use may cause injury to the fruit or vegetable.
