## DIRECTION FOR USE:

For use dilute one gallon of **Pineapple Lustr<sup>®</sup> 555 EC** with 24-27 gallons (*or to obtain the optimal dilution rate run small pretests*) of water and agitate to emulsify (4-3.5% solids). The emulsion may be applied to fruit by dipping, flooding or spraying.

## DIPPING OR FLOODING METHOD:

Apply one gallon of the diluted wax by dipping 300-500 pounds of fruit. Dip the fruit (but not the crown) in the diluted wax for 30 seconds and drip dry.

## SPRAY APPLICATION:

Use one gallon of diluted wax per 1000-1500 pounds of fruit.

**CAUTION:** If fungicidal protection is necessary run compatibility tests before commercial application.

**CONTENTS:** Food grade ingredients listed in 21 CFR.
