DIRECTION FOR USE: For use on citrus fruits, pome fruits, stone fruits, root & tuber vegetables, cucurbit vegetables, fruiting vegetables, tree nuts and other produce

Citrus: For postharvest application on clean citrus. Apply by spraying or dripping without dilution. Apply at a rate of one gallon of coating to 10,000 pounds of small or 12,000 pounds of large clean, dry fruit or for use in the Decco process by or under the supervision of Decco personnel.

Apples: This product is for post harvest application to clean apples. Apply one gallon to 8,000 - 10,000 pounds of apples by spraying onto the apples on a brush bed or other suitable applicator. For best results, clean fruit with an appropriate Decco Cleaner prior to application of **Decco Carnauba Premium**.

Mangos: Apply one gallon to 15,000 pounds of clean fruit by spraying. For dipping, dilute one part of **Decco Carnauba Premium** with four parts of soft water and mix well prior to use.

Sweet Potatoes: Apply at a rate of one gallon to 10,000-12,000 pounds clean and damp sweet potatoes.
