<u>Nectarines & Plums:</u> Dilute the product with two part of soft water, apply one gallon of diluted product to 25,000 lbs of fruit.

<u>Tomatoes & Cucumbers:</u> Dilute the product with three parts of soft water, apply one gallon of diluted product to 20,000 lbs of produce.

Bell Peppers: Dilute the product. with three parts of soft water, apply one gallon of diluted product to 30,000 lbs of produce

Mangos & Avocados: Dilute the product with two part of soft water, apply one gallon of diluted product to 25,000 lbs of fruit.

Others: For other commodities consult Decco personnel.
