

## **Decco Antifoam 032**

*Dimethyl Polysiloxane*

### **DESCRIPTION**

Some Decco processes, such as, drenchers, dip tanks, wash tanks, holding tanks, etc, in the field generate foam while in operation. In many instances foaming is undesirable, as it may tend to spot or mark the treated fruit pieces. The product is used as a shine enhancing agent in citrus wax and as an excellent food grade lubricant to break up "log jams" on pack side Electroscan delivery boards. Where necessary we recommend this food grade antifoam product for use by our service personnel or by our customers who use our products.

### **DIRECTIONS FOR USE**

**Decco Antifoam 032** is an emulsion of food grade water dilutable defoaming agent containing 30% silicone (a.i. Dimethyl Polysiloxane). The allowable direct use limit is 1 to 10 ppm in any food where foaming is a problem. Higher dosage of up to 1% could be used in wax tanks since the wax will be diluted by the weight of the fruit. Use the minimum quantity necessary to control foam in all re-circulating aqueous systems. Apply by batch application or by continuous feeding. For using in Spray bottles dilute one part with 30 parts of water. Mix well. Spray on foam blanket as needed.
