Decco Pearl Lustr[®] is a high shine food grade fruit coating for post harvest application on citrus fruit. The coating will reduce weight loss due to dehydration and serves as a carrier for most fungicides. The product is suitable for application on citrus for export to Japan.

DIRECTIONS FOR USE

For postharvest application on clean citrus. Apply by spraying, or dripping onto a brush bed. Use at a rate of one gallon of coating to 10,000 pounds of small or 12,000 pounds of large clean, damp/dry fruit or for use in the Decco process by or under the supervision of Decco personnel.
