DIRECTION FOR USE:

DECCO CLOR-OUT is a sulfite base solution for destroying of chlorine residues in packinghouse waste streams before disposal.

Dilute 1 part of CLOR-OUT with 100 parts water. Use 2.5 gallon of the diluted CLOR-OUT to neutralize 1000 gallons of water containing 10ppm chlorine

The diluted product can be directly injected to the waste stream using a low dose metering pump.

CONTENTS: Water, sodium bisulfite and stabilizers
