DIRECTION FOR USE:

For Mangoes: Apply one gallon of **Decco Mango Lustr®** Concentrate to 10,000 lb of mangoes. Apply through suitable spray nozzles to clean mangoes over brushes or rollers.

For Cantaloupes: Dilute one gallon of **Decco Mango Lustr®** Concentrate with one gallons of soft water. Apply through suitable spray nozzles to cantaloupes on brushes. Apply sufficient wax to wet the melons.

For Avocados: : Apply one gallon of **Decco Mango Lustr®** Concentrate to clean through suitable spray nozzles to over brushes or rollers.
