DESCRIPTION

Decco Multi-Lustr[®] is a high gloss coating intended for postharvest application to fresh clean tomatoes, cucumbers, peppers, zucchini, and other smooth-skin commodities. Application of this wax enhances appearance and reduces weight loss due to dehydration.

DIRECTIONS FOR USE

For Peach, Nectarine & Plums:

Apply the coating to clean and damp fruit by dripping or spraying on roller brushes. If used with fungicides, disperse the fungicide into the wax and keep the mixture agitated during the application.

For Vegetables: Tomatoes, Cucumbers & bell peppers

For postharvest treatments on tomatoes, cucumbers and bell peppers apply the coating clean and damp produce by spraying or dripping on roller brushes. Apply one gallon of coating to 72,000 pounds of tomatoes or cucumbers, 50,000 pounds of zucchini and 25,000 pounds of bell peppers.

For Other Crops: Consult Decco Sales or Technical Service Representatives for application on other commodities.

Do not over apply; use the minimum amount to cover the produce with a smooth and uniform coat.
