Single exposure studies indicate that this material is slightly to practically non-toxic if swallowed (rat LD50 2,830-8,270 mg/kg) or absorbed through skin (rabbit LD50 2,012-11,300 mg/kg), moderately to severely irritating to rabbit eyes, and slightly to moderately irritating to rabbit skin. All rats survived an 8 hr exposure to concentrated vapor. Following repeated skin contact, inflammatory effects on the lungs were observed in rabbits.
