### DIRECTION FOR USE:

**Apples:** This product is for postharvest application to freshly washed apples. Apply one gallon to 10,000 pounds of clean, damp apples by spraying onto the apples on a brush bed or other suitable applicator. For best results, clean fruit with an appropriate Decco cleaner prior to application of **Decco Lustr<sup>®</sup> 231**.

**Citrus:** For postharvest application on clean citrus. Apply by spraying or dripping without dilution. Apply at a rate of one gallon of coating to 10,000 pounds of clean, damp fruit or for use in the Decco process by or under the supervision of Decco personnel.

**Pomegranates:** Apply on clean and damp pomegranates; consult Decco representative for usage rates.

**Mangos & Papayas:** Apply one gallon to 15,000 pounds of clean fruit by spraying, or for dipping, dilute one part of **DL 231** with three parts of soft water and mix well prior to use.

**Sweet Potatoes:** Apply at a rate of one gallon to 8000 pounds of clean, damp sweet potatoes.
